2.0 OBJECTIVE

Any and all corrections and erasures must be initialed. **Each quote shall be signed in ink by an authorized representative of the respondent.** The contents of the quote submitted by the successful respondent of the ITQ may become part of the contract awarded as a result of this solicitation.

2.1 SCOPE OF WORK (SOW)

The Scope-of-Work ("SOW") contained in the Attachments describes the services expected for a Contractor to provide the STOFHD. Respondent must ensure that all such services contained in the SOW are provided for in every particular and shall meet or exceed the level of quality, availability, features, functionality, frequency, accuracy, and performance.

The silence of specifications or requirements as to any detail contained in this document or any of the attachments or exhibits, or the apparent omission from any specifications or requirements, or a detailed description concerning any point, shall be regarded as meaning that only the best commercial practices shall prevail and that only material and workmanship of the finest quality are to be used. All interpretations of the Scope of Work shall be made on the basis of this statement.

2.3 NOTIFICATION

Each respondent submitting a quote in response to this ITQ will be notified in writing as to acceptance or rejection of their quote. Release of notification letters should be within sixty (60) days of the quote submission date. STOFHD reserves the right to delay this action if it is deemed to be in the best interests of STOFHD.

**Scope of work
Fence & Gate Replacement**

- Supply all labor and materials.
- All materials being installed shall be of equivalent make/model to the original material being removed. (Unless it has first been approved by the Housing Department)
- All work performed shall be as per code(s).
- **Schedule of Values and proposed Schedule shall be submitted with proposals.**
- Supply all drawings/prints and any other documentation needed by the Building Department.
- Clean up jobsite daily and before the final inspection of the completed job.
- Call the Building Department & Housing Department for all inspections, before and during the installation process. (Darryl Kinchen 954-279-4784)
- Contact Housing Department for final inspection, prior to leaving the jobsite.

Fence Installation

The Seminole Tribe of Florida (STOF) Housing Department is currently accepting bids from Florida Licensed Contractors for Fence Installation project located at 16200 Reservation Rd. Okeechobee, FL 34974.

- Contractor shall provide all labor, material, equipment, and supervision to complete this scope of work.
- Contractor shall schedule locates with all utilities prior to digging for project address & **Shall include Public Works Department Dig Permit.**
- Contractor shall install vinyl coated chain link fence at locations from control points established by others for the address in this scope.
- Contractor shall provide quote based lineal footage established on survey provided at pre bid site visit meeting.
- Contractor shall provide and install minimum of 16 gauge 1-5/8 inch x 7 ft. black vinyl coated line posts, concrete incased in 12" diameter x 2' depth below existing grade, (In Ground) spaced at 10 ft. centers maximum.
- Contractor shall provide and install minimum of 16 gauge 2-5/8 inch x 7 ft. black vinyl coated corner or terminal posts at corners and gate openings concrete incased in 12" diameter x 2' depth below existing grade. (In Ground)
- Contractor shall provide and install 9 gauge 5 ft. high, black vinyl coated chain link diamond shaped woven fence fabric attached to top rail, line posts, tension bars, and terminal posts with

all necessary accessories for a complete chain link fence system also including 9 gauge bottom tension wire and minimum of 16 gauge 1-5/8 inch top rail and post caps.

- Install (1) – 16' solar powered electric roll gate at driveway including all tracks, keypads, remotes and necessary accessories for a complete solar powered gate system.
- Slide gate operator shall be Lift Master 24 volt DC- Traffic Commercial Slide Gate Operator Model # CSL24UL and shall include Lift Master 40 Watt Solar Panel Kit.
- Survey will be provided at pre – bid meeting.
- Clean up job site daily.
- **Contractor Shall Provide Alternate Price for Galvanized Chain Link Fence.**

- It is the contractor's responsibility to obtain any and all permits required to perform the task listed in the above Scope of Work.
